### **RESOLUTION #689**

CITY OF MONTEZUMA RESOLUTION AUTHORIZING THE OBLIGATION OF \$22,500 IN CASH MATCH and \$27,500 IN LEVERAGE FUNDS FOR THE PURPOSE OF \$50,000 OF MATCH AND LEVERAGE FOR A FY 2020 COMMUNITY DEVELOPMENT BLOCK GRANT FROM THE GEORGIA DEPARTMENT OF COMMUNITY AFFAIRS

WHEREAS the City Council of Montezuma possesses full legal authority to obligate monies from the City Water Fund for specific purposes; and

WHEREAS, the City Council has found it needful and necessary to submit an application to the Georgia Department of Community Affairs for a Fiscal Year 2020 Community Development Block Grant in an amount not to exceed \$750,000.00; and

WHEREAS, the required local cash match for a Community Development Block Grant is five percent (5%) for amounts above \$300,000, up to \$750,000; and

WHEREAS, the City Council will allocate a total of \$30,000 to be used for the required matching funds with any remaining balance to be used as leverage; and

NOW THEREFORE BE IT RESOLVED and it is hereby resolved that, contingent upon the receipt of the requested grant funds from the Georgia Department of Community Affairs, the City Council obligates a total sum of \$30,000 for the purpose of cash match/leverage, this action being necessary to carry out the aforementioned Community Development Block Grant; and

BE IT FURTHER RESOLVED that the City Council directs the Mayor or Mayor Pro Tem to execute and submit such documentation of this action as may be required by the Georgia Department of Community Affairs.
